

# Use of Cookies on the Website

## 1. About Us - Operator

## 2. Cookies

A cookie is a small text file that is stored in the user's web browser (e.g., Internet Explorer, Google Chrome, Firefox) on their computer (or other device with internet access, e.g., smartphone or tablet). This file ensures that visitors to our website can easily and quickly retrieve customized content whenever they return to a website they have visited before. Information from cookies is accessible only to the server of the company that created them, and to no one else. A cookie is only a "passive" file; it does not contain any other software programs that could be run on the user's device with internet access (computer, smartphone, tablet, etc.). Our websites use cookies. Cookies help us manage our website, provide its basic functionalities, and simultaneously help us understand how users use our websites. We also use cookies for analytical and statistical functions, such as recording the country of origin of our website users and the methods they use to visit our pages. Specifically, we use the following types of cookies: a) **Necessary cookies**, which ensure the proper functioning of our website, for example, ensuring the login function to the user account on the page or allowing you to switch between language versions of our pages and ensuring that your language choice is remembered. You can disable these cookies by changing your internet browser settings; however, the website may not function correctly without them. More information on how to change internet browser settings can be found below in the Disabling/Deactivating Cookies section. We process these cookies on the legal basis of pre-contractual/contractual relationships and our legitimate interest. b) **Analytical cookies**, which help us analyze how you move on our website, what content is relevant to you, and also to learn more about the demographics of our users. We process these cookies

on the legal basis of your consent. c) **Advertising cookies**, which we use to display targeted and relevant advertising. We process these cookies on the legal basis of your consent.

Some cookies are deleted from your device after you close the internet browser window (session cookie), while others remain stored on your device even after you finish browsing our websites (permanent cookie). Information about the storage period of individual cookies can be found in the List of Used Cookies below.

We inform users about the use of cookies on our websites through a banner located at the bottom of the website.

### Google Analytics
